

Swiss School Beijing - Tuition Fees Discount Policy

As a Swiss school abroad that is recognized and supported by the Swiss Government, the Swiss School Beijing is committed to admit all children of Swiss nationality that wish to join the school and meet its academic criteria (Swiss Federal Law on Swiss Schools Abroad). The Association Swiss School Beijing is aware that, in some cases, this might require a reduction of the school's tuition fees and has therefore issued the present Policy.

Eligibility

Any child of Swiss nationality, whether applying for admission or already admitted at the Swiss School Beijing, is eligible for tuition fees discount. The parents or guardians responsible for the payment of tuition fees (in what follows, to be called the Applicants) must apply for the discount. The discount is given purely based on financial needs and is not meant to reward academic performance.

Discount

The Applicants can request a discount of 25%, 50% and 75% in tuition fees.

Timeline

A discount is awarded for a maximum of one school year. A new application can be submitted for the next school year. Discounts cannot be backdated to a date prior to the school term in which the application was submitted.

Application process

A complete application requires the following documents:

- Completed and signed Tuition Fee Discount Application Form.
- Cover letter justifying the request.
- Copy of child's passport.
- Copy of Applicants' passports.
- **For both parents:**
 - A letter from employer(s) verifying **worldwide** annual salary (i.e. salary in China and abroad, if applicable), including all benefits and estimated bonuses.
 - A letter from employer(s) specifying the amount being contributed towards the child's tuition fees.
 - Copy of the most recent computerized worldwide salary statement(s).
 - If self-employed, a copy of the most recent **audited** financial accounts.
- For Applicants requesting 75% of tuition fee discount: confirmation from your canton of origin, showing that you have explored other scholarship and financial aid options.

The application is to be submitted to the Board of the Association Swiss School Beijing.

Approval process

The Board of the Association Swiss School Beijing reviews the application and decides the amount of tuition fee discount to be awarded. In doing so, the Board considers the following points:

- Financial background of the Applicants;
- Financial sustainability of the school;
- Creation and support of an environment that is conducive to learning for all students of the Swiss School Beijing.

As part of the approval process, the Board may ask for additional information from the Applicants.

Under special circumstances, i.e. when the Board considers that increasing the ratio of native speakers of a specific language in a particular class might benefit educationally all students in that class, the Board might consider the application for tuition fee reduction of children who do not have Swiss nationality but are native speakers of the language in question. Because of the structure of the curriculum taught at the Swiss School Beijing, these special circumstances can only be considered in Kindergarten and Primary school.

The Board may decline an application without having to provide justification for its decision. The decision of the Board is final.
